The Children (Performances) Regulations 1968 (as amended)

FORM OF APPLICATION FOR A LICENCE to the Kent County Council

(NOTE: It is important that this form, duly completed, should be sent so as to reach the licensing authority not less than TWENTY ONE DAYS before the first performance or activity for which the licence is requested, since the licensing authority may otherwise refuse to grant a licence).

 - (e) a statement by the child's parent that the child is medically fit for the proposed activity (where the application is for a licence for sport or modelling), or if the application is for a licence for a performance to be broadcast, medical evidence of child's fitness to perform.
